

**VOLUNTARY WAIVER, RELEASE, AND ASSUMPTION OF ALL RISKS
RELATED TO COVID-19/CORONAVIRUS**

The Centers for Disease Control (CDC) continue to warn of the health risks associated with COVID-19, which include serious illness and even death. The CDC cautions that the virus is highly contagious. Individuals showing no symptoms of COVID-19 (fever, cough, or loss of smell/taste) can still spread it.

Dillon Bass Lake, LLC (“Dillon Bass Lake”) is following CDC guidelines to reduce the spread of COVID-19, but cannot guarantee that you will not be exposed to COVID-19 while on Dillon Bass Lake premises. By choosing to enter, stay at, or participate in activities at Dillon Bass Lake, you agree and acknowledge that you are assuming any and all risks related to contracting COVID-19 and spreading it to others, including your family members.

RELEASE AND WAIVER AND ASSUMPTION OF ALL RISKS:

I fully understand the COVID-19-related risks involved in my entering, staying at, or participating in activities at Dillon Bass Lake. I acknowledge that due to the physical nature of activities and property, my use of Dillon Bass Lake may carry a greater risk of exposure to COVID-19, and that, even when all reasonable precautions are taken, there is an unavoidable risk of exposure to COVID-19. **I voluntarily assume all risks, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, I release and agree to hold Dillon Bass Lake harmless from, and waive on behalf of myself, my heirs, and any personal representatives, any and all causes of action, claims, demands, damages, costs, expenses, and compensation for damage or loss related to COVID-19 caused by or arising from my decision to use Dillon Bass Lake campgrounds.** I understand that, under this release and waiver, I forfeit any right to bring claims for personal injuries, death, illness or any other loss, including but not limited to claims of negligence related to Dillon Bass Lake’s efforts to reduce the spread of COVID-19, and I forfeit any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen. I have voluntarily elected to enter Dillon Bass Lake premises, and agree and acknowledge that I am voluntarily assuming any and all COVID-19-related risks by doing so. I additionally warrant and represent that I will follow any safety protocols or instructions aimed at reducing exposure to COVID-19 implemented by Dillon Bass Lake.

This full and complete liability waiver and release extends to Dillon Bass Lake, LLC, together with all its owners, board members, officers, agents, servants, independent contractors, affiliates, employees, successors, attorneys, and assigns. **I acknowledge that I knowingly, voluntarily, and willingly assume all risks and full responsibility for any COVID-19-related risk of harm or injury relating to my decision to enter and stay at Dillon Bass Lake premises, and participate in activities, no matter the severity, including death. I UNDERSTAND MY ENTRY AND STAY AT DILLON BASS LAKE AND PARTICIPATION IN ANY ACTIVITIES IS VOLUNTARY. I UNDERSTAND THAT THIS IS A FULL AND COMPLETE WAIVER AND RELEASE OF LIABILITY. I UNDERSTAND THE TERMS HEREIN, AND KNOWINGLY AND VOLUNTARILY SIGN THIS WAIVER AND RELEASE.**
